Verbs

Брать на себя (расходы) – to undertake costs;

Воспользоваться правом – to exercise the right;

Выполнять, совершать, проводить - to carry out (an agreement, payments), to execute (ex. this agreement is executed in the English language), to pursue (to pursue policy/remedy); to implement a task (реализовать, внедрить), to conduct business, to fulfill obligations;

Иметь преимущество – to prevail (the English version of the contract shall prevail); to benefit (the other party will benefit);

Нарушать права - to breach the rights, to be in breach of the rights, to infringe (~the interests of the company B);

Освобождать одну из сторон стороны от выполнения обязательств по данному соглашению — to relieve either party of obligations under this agreement;

Ослаблять, умалять - to impair (the rights of either party); **abridge (ограничивать)** (the interests of the company B);

Отменять, отзывать – to revoke (any prior agreements are revoked),

to relinguish a claim (отказаться от претензий),

to cancel (an agreement);

Относиться к – pertain to, refer to;

Подлежать – to be subject to (~ prior written notice);

Прилагать усилия – to make an effort to do sth, to endeavor sth;

Прекращать – to cease (~to use);



Подавать в суд – to seek legal advice, to take legal action,
to bring suit to the court (предъявить иск);
Подлежать – subject to (this clause is subject to prior written notice);

Руководить, осуществлять контроль – to manage, to monitor, to direct;

Ставить по угрозу – to threaten, to pose a threat;

to jeopardize (Ex: the company B shall take no action or inaction that may <u>jeopardize</u> or impair the relationship with any Client);

Требовать - claim, demand, request;

Удовлетворить требованиям – to satisfy requirements, to meet demands;

удовлетворить ходатайство – to grant an application.

Уполномочить, назначать - entitle, designate, assign.
